Dear School Friends and Families







Much excitement today (especially among playtime and lunchtime sandpit dwellers!), with the presentation of wonderful new sandpit toys. These toys will no doubt provide no end of creative fun, with many and varied 'contracting'

projects completed! A huge thanks to the Wallings, Southfuels and Southland farm machinery for this great support.

What a brilliant day for the Cross Country this week – Blue sky, sunshine......and snow! Great to see children giving their best and supporting each other. Cross Country is not everyone's favourite sport to be fair, and yet we not only had many winners come over the

line (e.g. the 3 Leach and 2 Mitchell 'rockets'!), but many with a 'winning' attitude who rose to the challenge of completing the course giving it their all. See over for our Northern qualifiers, who will be running at Mararoa on Friday June 2.



Later in the term (Week 9) will see achievement reports come home for our Year 4-6 children. You will notice a new, and (we believe) much improved format. Some parents of Year 1-3 children will have already seen this, and we've had some positive feedback so far in terms of the quality of information this new format enables. One significant change is that now there is no wording to state whether children are 'below', 'at' or 'above' National Standards. While there is a graphic which makes achievement clear against National Standards, we were conscious that use of the word 'below' in particular is potentially hurtful and detrimental to children's confidence, when most importantly they may well have been making steady progress through a great attitude and hard work.

Fidget spinners – Fun toys (I've enjoyed having a play with one myself!). They've been very well marketed to appeal to parents as a 'concentration tool'. I'll stick to just 'fun toy'. They don't do anything to help our kids be active and respectful listeners, an important life skill which we try to foster at school. So we'd appreciate your support with reminding your children to leave them at home if they have one, in line with our 'bring no toys to school' procedure, which eliminates potential issues around personal belongings going missing or getting broken, or detracting from learning activity during class. The children are able to enjoy lots of school-owned toys, games, and sports equipment while at school.



On Thursday we had Mark Herring from Using Technology Better working in classrooms alongside teachers. Mark is providing excellent ongoing professional development for staff in terms of how we can make the most of technology to enrich children's learning.

Thank you to Sandra Prebble from Dipton, who has joined our Buddy Reading team, kindly giving of her time on Tuesday mornings to read with children. We would love to hear from anyone else who would be able to spare an hour on Tuesday mornings (9:30-10:30) to help with this very worthwhile programme, which our children benefit so much from.

Police Vetting Urgent Reminder for All Parents

Please return Police Vetting Consent Forms to school for all parents interested in supporting with school events, e.g. camps, trips. We would like to get this process underway as soon as possible to ensure this is tidied up well before camps, etc. Also, we have been advised that as from 1 July 2017 a fee of \$8.50 + GST will be implemented by the NZ Police for each vetting. Thanks to those parents who have returned all their information as well as provided their required ID. If you need another copy of forms sent home please contact the office.

<u>MB</u>: If parents wish to be considered for attending **school camp** this year in Dunedin it will be **essential to have been vetted**. The same will soon apply for school day trips and volunteer helpers. A reminder that consent forms can be accessed on the school website under each weeks newsletter. Thank you for your support with this.

School Sore and Chickenpox Alert

We have had a couple of cases of School Sores recently in the school. Early signs are scabby sores on exposed parts of body. Medication is required to treat this infection. Children are infectious for 24 hours until after treatment with antibiotics has started, so they will need to stay at home during this time.

We have also had a few cases of Chickenpox recently. This disease is spread by coughing and sneezing, also direct contact with weeping blisters. Time between exposure and sickness is 13 - 17 days. Early signs are fever and spots with a blister on top of each spot. Children are infectious from up to 5 days before appearance of rash until lesions have crusted (usually about 5 days), so they will need to stay at home for one week from the date of appearance of rash.

Please keep a check on your child for any symptoms.

New Zealand Speech Board Tuition Opportunity

Children busy making all sorts of toys from marble rolls to teddy bears. Thank you to the parents and grandparents who came to help.


New Entertainment Books have arrived

Police Vetting Volunteers

Dear Parents

The Vulnerable Children's Act now imposes new responsibilities to the Board of Trustees with ensuring the safety of our children at school. To ensure we are complying with the requirements of the Vulnerable Children Act and to ensure the safety of our children the Board is <u>requesting permission</u> to Police Vet any person working or volunteering at Lumsden School or with Lumsden School children in any capacity e.g. parent helper, coach, overnight camps, day outings, clubs, driving children to events or any other activity where those volunteers are likely to have (or could have) unsupervised contact with students.

We <u>request</u> that any parent/caregiver/volunteer who may wish to help as parent helper, coach, on overnight camps, day outings, clubs, driving children to events or any other activity as part of Lumsden School's programs completes and returns page 2, signs the applicant authorization on page 3 of the attached document then returns these to school. Also please provide 2 forms of ID e.g passport, birth certificate, firearms licence, driver's licence; one of these must be photographic. The ID can be shown to Sharon or I. This will allow us to be prepared before specific events. These are valid for 3 years. We will keep a record of all parents/caregivers/volunteers who have been police checked and this will be updated as required.

Police Vetting is a responsibility of the Board of Trustees and is undertaken through the New Zealand Police Licensing and Vetting Service Centre.

All information received will be confidential to the Lumsden School Board of Trustees.

Only the requestor - the Principal - will open the returned information.

Please read the attached application carefully, complete page 2 then sign and date the "consent to disclosure" on page 3, then return this to the school office with the documents required.

Please note these steps are being taken as advised as being good practice as per the Vulnerable Children's Act 2014 with the safety of our children as the main priority.

 - Section 31(3) of the Vulnerable Children Act 2014 applies to this request (safety checks of core children's workers).

- The Police Vetting Service may disclose new relevant information to the Approved Agency after the completion of the Police Vet in the following circumstances:
 - The vetting request was submitted as part of a children's worker safety check under the Vulnerable Children
 Act 2014; and
 - The Police vet was completed within the past three years; and
 - The release of new information is considered justified under the Privacy Act 1993

The Vetting Service will endeavour to notify you prior to the disclosure.

- Information provided in this consent form may be used to update New Zealand Police records.
- I am entitled to a copy of the vetting result released to the Approved Agency (to be provided by the agency) and can seek a correction by contacting the Vetting Service.
- The Approved Agency will securely dispose of this consent form, copies of identification documents and the vetting result within 12 months of receiving the result unless a longer retention period is required by legislation.
- I may withdraw this consent, prior to Police's disclosure of the vetting result, by notifying the Approved Agency.
